Property Tax Pre-Authorized Payment Plan (PAP) Program Application Form

BENEFITS OF ENROLLING IN A PAP PLAN

- Payments will be deducted automatically from your bank account on the dates provided for in this application. Please note line of credit cheques will not be accepted.
- Pre-authorized payment will save you time, postage costs and penalties for missed payments.
- The pre-authorized payment plans allow for more effective budgeting with payments spread throughout the year.
- The program is free and may be cancelled at any time.

PROGRAM DETAILS

- To enroll, please print, complete and mail this application form to the address indicated below along with a **void cheque**.
- Your account must be paid in full prior to enrollment.
- An administrative fee will be applied to your account for payments returned “non-sufficient funds”. Two NSF items in a current year will mean disqualification.
- At such time as your account is in arrears you will be removed from the PAP program, unless you enter into a specific agreement with the municipality.
- Penalty and interest will be applied to balances in arrears in accordance with the Township’s Penalty & Interest By-Laws.
- Supplementary tax bills are not paid through the PAP program.
- A tax bill will be mailed a minimum of twenty-one (21) days in advance of the 1st due date in each billing cycle.
- **Written notice prior to the 15th of the month is required for any changes to your account.**
